Code of ethics for students

MISSION STATEMENT

THE MISSION OF THE UNIVERSITY OF THEOLOGY IS:

- TO UPHOLD AND REAFFIRM THE DOCTRINES AND PRACTICES OF THE SEVENTH-DAY ADVENTIST CHURCH AND SHARE THEM WITH OTHERS;
- TO OFFER ACADEMICALLY SOUND THEOLOGICAL EDUCATION TO SEVENTH-DAY ADVENTISTS WHO WANT TO CONTRIBUTE, BY THEIR SERVICE, TO THE REALIZATION OF THE MISSION OF THE SEVENTH-DAY ADVENTIST CHURCH, CALLING ALL PEOPLE TO BECOME DISCIPLES OF JESUS CHRIST AND PROCLAIMING HIS IMMINENT RETURN;.
- OFFER A SAFE ENVIRONMENT FOR DISCUSSION AND PROPOSALS ON THE ISSUES OUR CHURCH AND OUR WORLD ARE ARE GOING THROUGH;
- TO GROW IN ACADEMIC EXCELLENCE AND BE A REFERENCE POINT IN THE WIDER ACADEMIC WORLD;.
- BE OPEN TO STUDENTS OF OTHER DENOMINATIONS OR BELIEFS WHO SHARE THE SAME FUNDAMENTAL ETHICAL VALUES AND WISH TO JOIN US ON OUR JOURNEY TO SERVE THE WORLD.

Preamble

1. This Code is aimed at all students who make use of the teaching and research facilities of the Institute.
2. The Institute recognizes the centrality of the student community and of each individual student, promotes the use of spaces for sociality and collective discussion, promotes the right to study and guarantees the protection of the psycho-physical integrity of each student by encouraging the development of their personality and moral, civil and spiritual conscience.
3. The Institute considers that compliance by the students with the precepts and prescriptions contained in this Code is a necessary condition for the fulfilment of its mission.

Art. 1 – General rights and duties for the student

1. All students are required to ensure full compliance with this Code.
2. The student has the right to have their vocation for study indulged, to deepen disciplines, and to live a fulfilling formative, spiritual and relational experience on campus.
3. The student has the right to benefit from an effective tutoring service that supports him during his studies.
4. The student body, through its representatives or through other methods prepared by the Institute, has the right to express its opinion on the services offered by the Institute and transmit its requests through the inclusion of the various structures in the bodies.
5. The student has the right to live in equipped, healthy and safe environments and to enjoy services appropriate with his

or her just expectations, in line with what the Institute claims to guarantee.

6. The student has the right to request letters of recommendation to the Institute from third parties and agencies with a view to his professional advancement and learning.
7. The student is required to participate in the financial support of the Institute by paying the relevant university contributions.
8. The student undertakes to live his/her study experience in compliance with the principles and values promoted by the Institute and to get an education in an integral sense, combining academic training with ethical and human training. The behavior of the student within the Institute must reflect the inspiring motives and ideals of the same.
9. All students are required to respect the good name of the Institute and not harm its reputation, including through expres-

sions and comments on the web and social media; they are also required to maintain clothing that expresses respect for the Institute and enhances personal decorum.

10. Students are required to use resources, services and spaces in a responsible, decent and transparent manner. No one is permitted, in the absence of express authorization from the competent bodies, to use or grant to third parties research equipment, services, spaces and material owned by the Institute.

11. The use of the name, logo and symbols of the Institute is not permitted without prior authorization from the competent bodies.

Art. 2 – Educational commitment and relationships with the teaching staff

1. The student, through study and active participation in university life, is required to contribute to the cultural growth of the

academic institution and the society in which it is inserted.

2. The student is required to meet the educational commitments made upon enrollment, observing behaviors that favor the proper performance of teaching activities.

3. The student must take part with seriousness and sincerity in the activities of evaluating the teaching and services of the Institute.

Art. 3 - Rejection of all unjust discrimination and abuse

1. All students are subjects with rights, duties and values.

2. All students have the right not to be discriminated against by virtue of their religion, gender, sexual orientation, beliefs, physical appearance, language, ethnic origin, personal and health conditions, family choices.

3. The Institute does not tolerate abuse

and ensures victims prompt protection. It is committed to adopting strategies aimed at preventing, discouraging and removing discriminatory and oppressive behavior.

Art. 4 – Intellectual property rights, plagiarism, and artificial intelligence

1. Students are required to comply with intellectual property and plagiarism regulations.

2. The Institute condemns all forms of plagiarism, whether intentional or resulting from negligence. Plagiarism means the partial or total attribution of other people's terms, expressions, ideas, research or discoveries to oneself or to another author.

3. The use of generative Artificial Intelligence tools is allowed as research support, provided that such tools are used critically and responsibly. AI can be employed to

explore sources, organize ideas, reformulate, or clarify concepts, but it must not be a substitute for the individual process of reflection, analysis, critical development, and content drafting. Each paper must remain an original expression of the thinking process of the student, who assumes full responsibility for the paper produced, even if supported by digital technologies.

Art. 5 – Prohibited and Punishable Behaviors

1. The following behaviors are prohibited:

- all extracurricular activities that disturb the normal course of the university schedule;
- the use of telephones during class hours, which must at least remain with the ringtone deactivated; - the illegal reproduction of books and other publications protected by copyright;
- the removal of books and documents

from the library without the consent of the operators;

- the use of classrooms without the prior consent of the competent bodies;
- the destruction and/or misuse of resources, spaces and equipment belonging to the Institute;
- the use of alcoholic beverages on campus;
- the use of tobacco or derivatives inside and near buildings;
- the use or dealing of psychotropic substances of any kind;
- actions that may endanger the safety of others and oneself.

Such conduct, depending on the circumstances, may be considered serious for disciplinary purposes.

2. Any intentional or negligent behavior committed by the student in violation of the rules contained in the Statute and in

the Regulations for life on campus constitutes a disciplinary infraction.

3. Without prejudice to criminal and administrative consequences, the following are subject to disciplinary sanctions:

- the formation and/or presentation of certifications or false declarations;
- the alteration of the exam papers;
- the presentation of documents which, even partially, are the result of plagiarism or have been written by third parties;
- public demonstrations against faith and morals;
- sexual harassment and any other behavior harmful to the dignity of others;
- access to the Institute while intoxicated or under the influence of drugs, including the use of the same within the spaces of the Institute;
- behaviors that do not align with those indicated, which may serve as grounds for

disturbing the campus environment.

- failure to adhere to the provisions of the current Emergency Plan.

4. In the event of a disciplinary infringement, based on the seriousness of the offense committed, the following penalties apply:

- written warning or censuring;

- temporary suspension with loss of the exam session;

- suspension up to a maximum of 12 months;

- expulsion and deprivation of student status.

5. In case of plagiarism or copying, in addition to the penalties described above, the following are added:

- invalidation of the test;

- cancellation of the thesis.

6. In the event of student caused dam-

age and deterioration of equipment and/or structures owned by the Institute, the student is obliged to pay for the damage caused.

7. Disciplinary penalties are noted in the student's personal file and career history, subject to future merit assessments.

Art. 6 – Disciplinary Board

1. The College is composed as follows:

a. The Director;

b. The Administrator;

c. A member belonging to administrative staff;

d. A member belonging to the preceptory or chaplaincy;

e. a member belonging to the FAT teaching staff;

f. a member belonging to the DiLCAI teaching staff;

g. a student representative, in the person of the same in office, or of another figure indicated by the same, appointed by the Director;

h. The members of sub-items (c) (d) and (f) shall be appointed by the Director in agreement with the Administrator.

2. The College must have a mixed composition, men and women.

3. The quorum is set at 5 components.

4. The Disciplinary Board holds office for three years.

5. The College decides by majority of those present.

Art. 7 – The tasks of the Board shall be as follows:

1. The College shall be convened and chaired by the Director or the Administrator.

2. During its first session, the College ap-

points a secretary from among its members.

3. The Panel conducts the pre-trial phase of disciplinary proceedings submitted to it.
4. The Board decides on the sanction, accompanying it with a reasoned opinion in written form.

Art. 8 – Implementing provisions

1. All students and all staff members may report to facility managers and the Administration, individual and repeated conduct that is in conflict with this Code of Ethics.
2. The reports will be taken care of by the facility managers and the Administration only if they are carried out in a non-anonymous form.
3. Disciplinary responsibilities with regards to students or campus residents are vested, depending on the seriousness and nature of the conduct reported, in the fol-

lowing bodies:

- a. Individual teachers (FAT or DiLCAI);
 - b. Dean or vice-Dean of FAT or Director/Director of LCAI;
 - c. Academic college;
 - d. Director/Administrator of the Institute;
 - e. Disciplinary Board.
4. Verbal recall, or censure, is imposed by facility managers or in the most serious cases by the Director or Administrator.
 5. Penalties exceeding censorship are imposed by academic collegial bodies or the Disciplinary Board.
 6. The application of disciplinary measures must meet criteria of reasonableness and fairness.
 7. The Director, having become aware of conduct seriously detrimental to this code and the good reputation of the Institute, must carry out the preliminary investiga-


tions necessary to evaluate its validity, and must, if so, submit the conduct to the evaluation and judgment of the Board of Discipline.

8. The student or other subject subjected to disciplinary procedure has the right to confidentiality and to a rapid procedure that does not last beyond thirty days.
9. The student must be heard by the College during the preliminary investigation phase and present defense briefs or testimonies in his defense.
10. The disciplinary proceedings of the College may end with dismissal, a written warning or a sanction of temporary suspension from studies or/from on-campus presence.

Art. 9 - Indignity

1. Sanctions imposed following a serious violation will be noted on the student's academic career.

Academic Rules

Academic Rules

All information contained in this booklet **MUST BE READ**. Please keep it for further reference since you will need it during your stay at Villa Aurora.

Registration

Prior to arrival the DiLCAI office must receive a scan or image of each student's passport, normally uploaded on the ACA website, so the resident permit process and tram pass process can be initiated. Once students arrive, they must bring their physical passport to the registrar's office for official photocopies to be made; after which the original will be returned to the student. If needed, personal photocopies of the passport can also be made. The University is not accountable for any theft that takes place in the dorm rooms, so do not take any unnecessary risks. Students are encouraged to lock their rooms when they leave.

Orientation

The first day of each trimester is dedicated to the new students' orientation. Details on these procedures are given upon students' arrival on campus. The information given during the orientation on campus will be in addition to the information given during the emailed zoom meeting, scheduled for each trimester and done well before the official arrival dates.

Interviews

Prior to arrival, students will be given a list of available courses in order to plan their academic year. We strive to keep students informed and up to date with course information to avoid any conflict or misunderstandings on the way to reaching their goals. If students are interested in a minor or major (from participating home universities) they will be presented with the requirements for those plans of study. Students should always keep in contact with their home schools and keep them informed of their plans.

Upon arrival, each student will be interviewed or tested by the language teachers to give them a better understanding of the student's interests, goals, and needs regarding the Italian language. This interview also helps the teachers to form the different language class groups.

Didactic material (books, folders)

Students will receive the following material: a tote bag, books, a pen and pencil, a notebook, the student guide (also available digitally upon request) which must be read closely, the lesson schedule for the term, forms to be signed, and other varying information.

Worships

Throughout the week, we will dedicate moments for brief worship sessions often accompanied by songs, allowing our staff, teachers, and students to share their personal experiences. As time progresses, our students may take the lead in the worship services, including but not limited to participation in the sermons and/or music. Important administrative announcements will be made during these gatherings, and it is crucial for students not to miss this vital information. Therefore, we highly encourage that every student attends the worship sessions that are held on campus to enrich their

spiritual and social life here at Villa Aurora. The students' spiritual participation throughout their time in the program is evaluated using a point system. Every spiritual moment is equal to a single point as follows, and students are required to acquire a total of 24 points per trimester. At the end of the trimester the summation of the points will be graded according to the grading scale accepted across campus, and this will be included under the General Conduct evaluation in the final grades seen on the official transcript of each student (see General Conduct Evaluation, p70). Our main spiritual meetings are as follows:

- Wednesday 8-9 pm –Dorm worship 'Salottino' (1pt)
- Friday 8:30 pm – Vespers (1pt)
- Sabbath 10:00 am– Talk About It: special sabbath school in English (1pt)
- Sabbath 11:00 am – Sabbath service in the main church, offered in Italian
- Sabbath once a month – we hold a special church service on the campus grounds, titled 'Sabato del Campus' (1pt)
- Spiritual Retreat we take a school-wide trip in the Tuscan mountains for a spiritual weekend together (required) (1pt/spiritual moment, 4pts total)

Break

There will be a 15 minute break at 10.40 am every school day.

Electronic devices

Computers, iPads, cell phones, and electronic devices cannot be used in class unless it is allowed by the teacher, in order to encourage participation and attention.

Academic Rules

Homework

Students must complete their homework on time in preparation for that day's lesson. Homework will be checked for completion in class, and the correct answers will be given. If students require a more in-depth explanation outside of class, teachers will be available to help during tutoring hours. A timetable for tutoring hours outside lesson hours will be posted.

Tests & Exams

Test dates will be posted during the first few weeks of classes. Since learning is built from foundational building blocks – particularly language – each exam will include material from previous lessons alongside new content. Students who are not present on the day of the test will automatically receive an 'F'. More information about the exams will be discussed in class.

**In case of illness, teachers will evaluate each case and they will decide if the test can be rescheduled or not.*

**Special cases should be discussed with the teachers before the scheduled date.*

Final grades

Grades will be given according to the syllabi and according with the teacher's discretion, considering the performance of the student including participation and punctuality. Final grades include the following items (these may vary depending on the course syllabus):

Absences

The following absence policy applies to all classes regarding the Italian language (grammar, composition, etc.). All other classes have their own policy which will be outlined in the course's syllabus.

The learning environment for language acquisition diverges from what students might be accustomed to. Active participation in classes is of vital importance, as students engage in collaborative learning with their peers and teachers. Attending classes regularly is vital for individual success and keeping pace with the course. Each student's presence is crucial for fostering a supportive and effective learning experience. Thus, students that are continually absent and/or unprepared hurt not only themselves, but also hinder their classmates as the teacher must use class time to re-explain material that has already been covered. With this in mind, the absence policy is as follows:

- Absences up to 20% of the total hours of the course are tolerated as long as students catch up for what they have missed. For example, if a course meets for 30 hours during the trimester, this means that six missed hours are tolerated. **NOTE:** an absence on a day with two hours of the same class will result in two absences for that class.
- For courses that meet 12 hours or less per quarter, students can **ONLY** miss **ONE** class (more details will be provided in the syllabus).
- **It is the student's responsibility** to get the information on the lesson missed, homework assigned, and to keep up with the class.
- Three (3) tardies are equal to one (1) absence.

Academic Rules

- After 5 minutes students will be considered tardy and after 15 minutes they will be considered absent.
- Each absence beyond 20% of the total course hours will lower the grade component encompassing attendance.
- If students are absent for over 50% of the entire course, they will fail the course.

We ask students to please be mindful of not planning personal trips during tests, exams, and programmed trips, as these absences will affect your final grades (see *Planning Academic Year*).

COURSE POLICIES

Full Time Student Requirements

Students must take a minimum of 12 (and a maximum of 18) credits each trimester to be considered full time. Because of ACA regulations, we cannot guarantee that credits above 18 will be accepted by the respective schools.

If students wish to take more than 18 credit or less than 12 credits, they must provide Villa Aurora with a written permission from their university registrar, to avoid having those credits renounced by their school upon their return. This written approval will be attached to the transcript.

It is recommended that students take at least 15 credits, and not the minimum of 12 credits. Students that take only 12 credits, risk losing their full time status if they fail a class due to unforeseen events such as absences for sickness or other circumstances, **this may have some effects such as losing student loan funding.**

Add/Withdraw Policies

If a student wishes to drop or withdraw from a course, they must first inform the program director, who will then record the students' withdrawal on the necessary documents.

Students can withdraw from any course with no further consequences. In Italy, students may withdraw from any class at any time without penalty. However, we require students to complete each trimester with at least 12 credit hours on their transcript (see Full Time Student Requirements). If a student falls below this minimum, they will receive a "W" on their transcript, which their home university may automatically convert to an "F". Withdrawals must be discussed on a case-by-case basis with the professor and director. If a student wishes to join a course already in session, they must first obtain permission from the course instructor to see if it is still possible to do and then inform the language department director.

Elective Courses

An elective course will not be offered unless there is a MINIMUM of 5 students signed up for it or if there is a special need.

When a course, whether required or elective, is CROSS-LISTED, please indicate to your instructor and the DiLCAI's director your credit preference (HIST, ART, HMEC, LITT, etc.)

Auditing Courses

After reaching the required minimum of 12 credits, students may choose to audit (AU) existing elective classes for no academic credit. Audits must be discussed on a case-by-case basis with the professor of the course in question and the program director. Students may only audit a course from the beginning of the class, and not as a mid-quarter option. The attendance policy still applies just as if it was taken for regular credit, however homework and tests will not be required. If the attendance policy is not respected, students will be asked to leave the course (see Absences pg. 30). Students who are already taking 18 credits will still be allowed to audit elective courses but they will be asked to pay out of pocket for the material used in class and for any additional activities such as museum visits.

Additional Certification

Subject to scheduling availability, at the end of the year, students will have the opportunity to take the state-certified PLIDA exam, which acknowledges their proficiency in the Italian language.

Students who wish to take advantage of this opportunity are required to attend all the preparation classes offered during the second and third quarter.

Registrar / Course policies

The PLIDA (Progetto Lingua Italiana Dante Alighieri) certificate is an official Diploma issued by the Società Dante Alighieri under an agreement with the Ministry of Foreign Affairs and with the academic approval of the “La Sapienza” University of Rome. The PLIDA is also recognized by the Ministry of Labor and Social Policies and by the Ministry of University and Research as a qualification for the facilitated university enrollment of foreign students.

There are 6 levels, from elementary to advanced.

Almost every one of our students in the past has passed their respective level. Usually students take anywhere from A2 to C1. B2 or C1 will allow most students to waive the language requirement to enroll in Italian Universities. These levels have been established by the European Union.

PLANS OF STUDY (OTHER UNIVERSITIES)



Most of the American universities partnered with ACA are now accepting the Italian minor, though a specific program may not yet be in place. Upon your arrival, we will check together with your school to see what will be required, and decide which courses to take.

The students who are interested in a Minor or Major from Villa Aurora, and are from American Universities other than those previously listed must contact their Registrar's office for more information.

How are the class groups formed?

Students will have a brief interview or placement exam with the teachers who will then decide which group to place students in.

What if I get placed at the wrong level?

During the first week, any student who feels that they have been placed at the wrong level can request that the director review his/her situation. More information will be given during orientation.

What classes will I take?

Every quarter, students will communicate with the DiLCAI's director to choose the courses they want to take. According to their language level and the electives chosen, students will be registered to attend several hours of classes each morning which will help them to learn Italian grammar, composition, conversation, art, and culture. In the afternoon students will be able to attend diverse workshops such as Sculpture, Fashion, and Mediterranean Cuisine, among others.

Can I audit classes?

After reaching the required minimum of 12 credits, students may choose to audit (AU) existing elective classes for no academic credit. To audit a class, students should indicate this at registration or within one week of the start of the trimester. The attendance policy still applies just as if it was taken for regular credit, however homework and tests will not be required. Students who are already taking 18 credits will still be allowed to audit elective courses but they will be asked to pay out of pocket for the material used in class and for any additional activities such as museum visits.

What happens if I miss a class?

Unexcused absences or incomplete assignments will lower the student's grade. It is the student's responsibility to figure out what was done in class and be ready for what's due the next day.

- Three tardies will be considered an unexcused absence.
- Students who miss 50% of the class will receive a failing grade and will not be able to withdraw from the class.
- Please note that written excused absences due to illness or medical reasons outside of the 20% general allowance (see Absences pg.30) can only be issued by a medical professional in the form of a sick note. If you find yourself in such a situation, or any situation requiring medical attention, we request you to reach out to the campus deans for assistance.

And if the teacher is absent?

Students are required to wait a minimum of 15 minutes; after that, if the teacher has not arrived or sent a message for the students to wait, they should inform Antonietta or her assistant. If the absence is prearranged, the teacher will find another time to make up the class according to your schedule.

What kind of credits will I receive?

- Students coming from the U.S.A. or Canada through A.C.A. will receive a composite grade if they are in beginning (100 level) or intermediate (200 level) level, or a grade in each subject if they are in advanced (300 or 400 level) level. In either case, they will receive a total of 12-18 quarter hours of credit or 6-9 semester credits, according to the courses taken.
- Students from other countries will receive a document, in the language of their preference (Eng-

lish or Italian), certifying their participation in the course, the grades or marks received, and the level of the European Framework.

How will I receive official transcripts?

- ACA students

At the end of each quarter, Villa Aurora will send all transcripts to the ACA headquarters in Maryland. Then ACA will send these transcripts to the students' home universities. Once this takes place, these transcripts will become a part of the student's permanent record at his/her home university. Transcripts from the student's home university will include the grades received through ACA at Villa Aurora.

- Students from other countries will receive an official record of their work at the end of the year.

- All students normally receive an unofficial copy of their grades each quarter.

- Additionally, during the graduation ceremony at the end of the school year, students who have finished the school year satisfactorily will receive a certificate of completion of the program

Rules for campus life

These few, simple rules are here to help make your stay at Villa Aurora a pleasant one. Please, do your best to respect them. We ask that you keep this booklet available for further reference during your stay.

Rules for campus life

Arrivals/Departures

Students enrolled in the ACA program are permitted to stay on campus for two nights before the official arrival date, with no additional charge, as well as two nights after the official departure date. Meals are included. Food and lodging for any days beyond those previously mentioned will come at an additional charge, and students should make arrangements with the administration ahead of time.

Expected behavior and disciplinary action

Students are expected to be respectful towards others, the school, and themselves. They are expected to act in accordance with the principles and lifestyle of the Adventist church. As such, smoking, drinking alcohol, or consuming drugs are forbidden. Lack of adherence to these rules will result in disciplinary action. These may include losing off-campus privileges, participating in community service, or grade demotion. Extreme situations will be dealt with by the school disciplinary committee, and may result in being expelled at any point in the year. Students will be sent home at their personal expense, with no refund.

General Conduct Evaluation

Students enrolled in the DiLCAI program will be

assessed on their overall conduct and engagement in school-sanctioned activities throughout the duration of the program. This includes, but is not limited to, participation in worship services, maintenance of dormitory cleanliness, and demonstration of respectful and responsible behavior both inside and outside the classroom. This holistic evaluation will be conducted collaboratively by the deans, chaplain, faculty, and administrative staff. The resulting General Conduct grade will constitute up to 20% of the final grade in each course listed on the student's transcript. It is important to note that a low mark in this category may adversely affect a student's GPA at their home institution.

Honesty

Theft, fraud, and dishonesty are not tolerated by the school, and in such cases it will be necessary for the deans to intervene.

Room Deposit

The initial room deposit is 60 euros per quarter. The deposit covers potential damage to the dorm rooms and extra fees that may be incurred. The deposit will be returned to the student as part of the check-out procedure prior to the student's departure.

Non-transferability of the Right to Meals and Accommodation

The right to use student housing or to receive meals in the cafeteria, regardless of how it is granted, is strictly personal and cannot be transferred to others under any circumstances. No one may take the place of the holder of this right in the accommodation or when consuming meals, even temporarily. Likewise, keys (including electronic ones), badges, vouchers, or any other device or official document provided by the Institute may only be used by the rightful holder and may not be given to others.

Social, spiritual and cultural life

As part of the Seventh-Day Adventist educational system, one of our goals is to help students grow spiritually. We consider it important for students to attend worship programs organized by both the school and local church. Every spiritual moment is equal to a single point as follows, and students are required to acquire a total of 24 points per trimester. Their participation will be considered part of the General Conduct Evaluation score.

- Wednesday, 8-9 pm – Dorm worship 'Salottino' (1pt)

Cafeteria

The cafeteria serves three vegetarian meals per day, each offering a different Italian dish. The cafeteria is able to accommodate students with food allergies or specific eating preferences with prior communication. On holidays, such as Thanksgiving and Christmas, the cafeteria hosts special meals and festivities for students spending the holidays on campus.

Sabbath Kitchen Duty:

Every student or staff member is requested to help in the cafeteria on Sabbath at least once or twice during the school year. Students will be informed ahead of time in order to ensure scheduling flexibility.

Dorm Life

Dorm Rooms and Bathrooms

Bedrooms may be personalized with temporary decorations. Every student is responsible

for cleaning their bedroom and tidying up after themselves in public spaces. Garbage in the dorms must be sorted into collective waste bins according to the contents, e.g. paper, plastic, organic waste, etc. Every dorm room is provided with a broom, mop, bucket, and cleaning supplies, and the dorm will supply essentials such as toilet paper and light bulbs upon request. The dorms have a heating system used during the winter, but unfortunately there is no air-conditioning system available for use during the summer. Every dorm room is equipped with one or more fans to help keep the dorm cool, and anti-mosquito plugs are available for use in the dorm rooms as well. Students are responsible for purchasing anything else they might need or want. Any noncompliance related to dorm life and cleanliness will be dealt with by the deans. Villa Aurora values students’ privacy, but may conduct general room inspections or inspect for banned substances at any time. If a student loses their keys, they should communicate with the administration and will be responsible for purchasing the new keys.

Dorm Storage

Personal belongings may only be stored in students’ dorm rooms or designated areas. Hall-

ways and public spaces should be left clear for safety reasons. Villa Aurora is not responsible for theft within the dorms. Students are encouraged to always lock their doors and keep the key with them in order to avoid problems. We suggest that any valuable items be placed out of sight, and students may speak with the deans if they would like to place any items or documents in the school safe. Lost room keys will cost 7 euros to be replaced.

Curfew and Quiet Time

All students are subject to curfew during their stay at Villa Aurora. Curfew is at 11:30 PM Sunday through Friday, and is extended on Saturday to 1:00 AM. Quiet time is from 10:00 PM to 7:00 AM Sunday through Friday, and is from 11:30 PM to 8:00 AM on Saturday. Any noncompliance related to curfew or quiet time may result in disciplinary action.

For security reasons, hygienic concerns, and organizational standards we kindly ask you to read and study the following regulations for The Life on Campus.

Dorm Rules

Students are not allowed to keep perishable

food items in their bedrooms.

Students are not allowed to bring outsiders into the dorms without the deans' authorization.

- Students are not allowed to enter the bedrooms of students of the opposite sex without the deans' permission
- Students are not allowed to use electrical or gas appliances to cook in the dorms
- Students are not allowed to camp in any form on campus without the express consent of the deans
- Students are not allowed to remove Villa Aurora's linens, blankets, or furniture from the dorms
- Students are not allowed to use fire in any way

Noncompliance with these rules will result in disciplinary action.

Laundry

Students have access to the campus laundry room every day between the hours of 7:00 AM and 11:00 PM, and are asked to be quiet in the laundry room after 9:30 PM. It is important to respect the hours as an alarm system is in place during the off hours and setting off the alarm will result in a 20 euro fine. The laundry room provides the opportunity for students to switch

out dirty linens and towels once weekly, but it is the student's responsibility to take care of any other laundry with their four personal laundry tokens. Laundry staff are available Thursday mornings between 7:00 AM and 13:00 AM to collect dirty linens and return used laundry tokens to the students. Additional laundry tokens may be purchased at the reception of CasAurora for 4 euros. Further explanation will be provided upon arrival.

Library Rules and Regulations

Every student has the right to use any available books, periodicals, and any other bibliographic material in the library. Students may check out up to 5 books for a period of 15 days. Books maybe be borrowed for a 15 day period, a 7 day period, or for an overnight period. Students who lose or damage library books will be charged for the value or damage to the book. If a book is not returned on time, students will be fined 30 cents a day until it is back.

Access to the Buildings on campus

Certain buildings on campus are protected by a private security alarm system. The school and multipurpose buildings are alarmed, and may not be entered between 12:00 AM and 6:00

AM. Unauthorized personnel entering those buildings during that time will set off the alarm system and security will be alerted. Anyone responsible for triggering the alarm system will be charged 20 euros by the security company, and may receive disciplinary action by the administration. For the safety of the students, it is forbidden to enter anywhere there is a sign prohibiting access. Noncompliance with these rules will result in disciplinary action.

RULES FOR TOURS



WHEN A SCHOOL TRIP OR TOUR IS SCHEDULED, ALL THE INFORMATION NECESSARY FOR THE TRIP WILL BE PRESENTED IN PERSON AND SENT TO STUDENTS ON THE VILLA AURORA ACA GROUP CHAT.

- Punctuality is **IMPERATIVE**. Those who are late for a scheduled tour will be left behind at Villa Aurora (late departure means possible missed arrivals or important connections with trains, boats, special appointment to museums, etc.)
- The same process is required to return to Villa Aurora, so it is **EXTREMELY** important for students to arrive on time to previously appointed meeting locations.
- Students should participate unless they are sick or have previously notified the faculty in charge to expect their absence. If students choose not to participate in a scheduled trip, there will not be any kind of reimbursement. Please be aware that missing a programmed trip may **ADVERSELY AFFECT** a student's grade in Fine Arts & Monuments.
- While on the tour students should stay with the group while touring. There must be a **PREVIOUS** agreement with faculty in charge if the student is not to remain with the group. However there is usually free time provided for the students to explore for themselves on the tours.
- It is **IMPORTANT** for students to have the contact number of faculty during any tour prior to venturing on their own for communication and safety reasons.
- Some tours will require students to bring a sack lunch and/or breakfast. Students will need to stop by the cafeteria prior to such trips to pick up and/or make their meal. Announcements will be made beforehand in such cases with more details.
- Beach towels are available upon request. If these are lost, student will need to pay 10 euros. **(Laundry towels cannot be taken outside of campus)**

FAQ Frequently Asked Questions

What does the program price include?

Program tuition includes housing, meals, school trips, and a monthly tram pass. Necessary textbooks are also provided, as well as transportation to and from the airport or train station at the beginning and end of the program. Any other expenses will be covered by the student out of pocket.

What if I withdraw from the program?

Students withdrawing early from any quarter must immediately notify the ACA office in Maryland, indicating the date of withdrawal from the program and their expected date of arrival back home. Students should talk to the ACA program director at the host campus in order to work out refund details. They should send the following information to the ACA office as soon and possible:

1. An ACA withdrawal form with the date of withdrawal, reasons for withdrawal, and any other pertinent information.
2. The balance on the student's personal account. Any balance owed to the student will be refunded by the host campus, not the ACA office. Unused funds will be refunded by the host school directly to the student and must be received prior to the student's departure. ACA is not responsible for uncollected refunds. Students withdrawing early will not be refunded for the \$100 deposit, and will pay for the length of their stay as determined by the host school. Some prepaid tour fees may not be refunded by tour providers, in which case the student will also not be refunded. **No refunds will be given for room and board or tuition after the student has completed one month of the academic quarter.**

What is my personal account at Villa Aurora?

A student's personal account is similar to a safety deposit, and is made up of 60 € per quarter to

cover any loss or damage to school property incurred during a student's stay. This may include linens, towels, keys, books, or laundry tokens.

What happens if I need medical attention while at Villa?

If a student is unwell they should contact the dean immediately. The deans will provide assistance or transportation to a medical professional if needed. Class absences will be excused ONLY by an official sick note written by a medical professional. Regardless if an absence is excused or not, it is the student's responsibility to contact their teacher to make up any work and the DiLCAI offices to inform them of the absence ahead of time.

Do I have insurance coverage at Villa Aurora?

ACA students are covered by ACA/ARM insurance. Villa Aurora will temporarily cover costs incurred by illness or accidents, however, an insurance form will be filled as soon as possible in order for the school to be reimbursed by ACA, and the students will be contacted to provide any details or signatures required. Any medical help required while traveling, apart from school trips, will be temporarily covered by the student before they are reimbursed by ACA. Medical receipts should be given to the deans in order for a student to receive their reimbursement.

Note: European students must bring a letter from their country's Social Security Office to be able to receive medical attention in Italy (form E111). Students from anywhere outside the E.U. or the U.S. must have insurance coverage for illness and accidents from their own insurance provider before arriving in Italy.

What does insurance cover?

ACA/ARM insurance covers all emergency incidents and treatment, including medication. Cover-

age begins 15 days prior to a student's arrival on campus and lasts 15 days after their departure. For more details, please contact the ACA office.

Note: ACA/ARM insurance does NOT cover over-the-counter medications, such as Nyquil, allergy medications, or non-prescribed medicinal creams, in addition to treatment of chronic or preexisting illnesses. Normal dental work, eye examinations, or regularly scheduled medical examinations are NOT covered, unless they result from an accident that occurs during a student's stay.

Quiet Times

Quiet hours are from 10:00 PM to 7:30 AM Sunday through Friday, and 11:30 PM to 8:00 AM on Saturdays.

Is there a dress code?

Clothing at Villa Aurora should reflect modesty and professionalism. Shoes and shirts are required in all non-recreational public spaces, and pants must be worn at the waist. Swimsuits or exercise clothing should be appropriate and modest, and clothing with offensive or derogatory graphics, slogans, or phrases may not be worn. Pajamas may not be worn outside the dormitory areas.

Is worship required?

Students are required to fulfill the worship points per trimester as mentioned on page 27. Please refer to this explanation for more details.

Do I have to clean my room?

Yes! Rooms should be kept tidy all the time. Room checks are possible, and everyone should be responsible for the upkeep of their own space. In the event of noncompliance, the deans will talk

and come to a solution with the student.

Where can I withdraw money?

Students can find ATMs in all Italian banks and at some convenience stores. Bank of America cardholders can withdraw money from BNL ATMs without additional fees. The closest BNL ATM is nearby on Viale Morgagni.

Can I take weekend trips?

Students with plans to be off campus overnight must inform the DiLCAI Assistant ahead of time over Telegram with the dates and destination of the trip. This information will only be used in case of emergency and will only be shared with the administration. Students under 18 must have written permission from their parents, sent to the DiLCAI offices ahead of time. In addition, the minor must be accompanied by a monitor or adult. Failure to notify the administration may result in disciplinary action.

Can I stay on campus during Christmas break?

Students are allowed to remain on campus during Christmas break, but they must notify the administration ahead of time. The school dorm and cafeteria may have different services during the holidays, so students should make arrangements with the deans and kitchen staff.

Is there a laundry service?

The school provides the opportunity for students to receive clean towels and linens weekly, and students have access to the laundry room throughout the week for personal use. For more information, see Laundry Rules.

Is internet available?

Yes! Wi-Fi is available in all school buildings and dorms. Students will receive a personal username and password upon arrival.

Are there mosquitoes?

Yes, there are mosquitoes. The deans provide each dorm room with a mosquito-killing plug-in, but we recommend students bring or buy mosquito repellent and/or mosquito nets.

Who do I ask if I need light bulbs, toilet paper, etc.?

Students should contact the deans if they need supplies such as light bulbs or toilet paper in the dorms. Students may ask them in person, or reach them on Telegram.

Are there stores nearby?

There are many stores near Villa Aurora. If students are looking for something specific, a dean or staff member can help them find the right store. The nearest grocery stores are Carrefour, Conad, or Coop. Another great option for toiletries and extra cleaning supplies is Caddy's.

Is the water safe to drink on campus?

Yes, all campus water has been treated and is safe to drink. The cafeteria, dorms, and school building all have water coolers that students may use throughout the day to fill water bottles.


Is dating allowed on campus?

What needs to be done before leaving Villa Aurora?

Before leaving, students should fold linens and towels and leave them on their bed, take out their trash to the dumpsters and clean the room, return laundry coins to the laundry room, and return their keys to the deans. Students may also get their 60€ deposit back, but must first have their room inspected by a dean. Any damages will be covered by the deposit, and students will receive the leftover sum in cash upon check-out.

HOW CAN MY PARENTS SEND ME MONEY?

If, for any reason, your parents decide to send you extra funds while you are here, there are a couple of ways to do it:

- Perhaps the simplest way would be for them to transfer funds directly to your bank account, which you can then withdraw from an ATM here.
- It is also possible to make a Bank Transfer. If you choose to do so, you should make use of the following information:
